## LEGAL NOTICE OF CRIMINAL ACTIVITY AGAINST THE FIRM

On January 4<sup>th</sup>, 6<sup>th</sup>, and 13<sup>th</sup> of the year 2023, report to RACCOON TECHNOLOGIES INCORPORATED was made of a pattern of false and criminally organized claims to intimidate, extort, blackmail, and menace clients by representatives of Veronica Marie Petersen, Donald Jonathon Beal, FAIRWAY INDEPENDENT MORTGAGE COMPANY, IX NETWORKS LLC, ROBERT HALF TECHNOLOGIES, TEK SYSTEMS, COGENT COMMUNICATIONS INC., EQUINIX, DIGITAL REALTY TRUST INC., NTT COMMUNICATIONS, NTT/VERIO, NTT AMERICAN INC., NTT GROUP et al; known to us by 2323 Bryan St Suite 2670 Dallas Texas 75201 and 11816 INWOOD RD #1115 DALLAS TX 75244.

These claims involve fraud and forged email to impersonate a CONTRACT AT LAW not duly made or enforceable and obtained by violent duress and coercion including assault at gunpoint at 722 S Haskell Ave Dallas Texas 75223 in the year 2002, involving carjacking and attempted murder duly reported.

We are as of January 20<sup>th</sup> 2023, aware that parties in DENTON COUNTY involved in a civil suit did flee to DALLAS COUNTY to evade civil process in that suit; and that parties at the prior INWOOD RD address used for IX NETWORKS LLC and letters of extortion initiated January 28<sup>th</sup> 2022 by DIRECTOR of IX NETWORKS LLC Donald Jonathon Beal, then employed in COMMERCIAL USE with YOUTUBE.COM and editing to create false claims of extortion employed in identity theft of CHARLYCE ANN KLEPPER after he death March 2<sup>nd</sup> 2022 and in May and June and October and November of 2022 and January of 2023, constitute an ongoing pattern of felony activity evident in 2003 September letters of FALSE EMPLOYMENT and repeated narrative fraud July 7 2011 and by user myluv187 to extort and threaten arson, serious physical bodily harm, sexual assault, and "in rem forfeiture" for civil debt void by Federal Law and affirmed criminal by State Law made effective and mandatory February 21 2017.

These claims are part of a \$2.2 billion grant fraud, in embezzlement of United States Federal Funds paid to the State of Texas and State of Oklahoma as State policy contrary Federal Register December 20 2016, and contrary United States Public Policy in impersonation of a UNITED STATES AGENCY in seditious conspiracy.

Destruction of U.S. mail (rifled mail, verified by the U.S. Postal Inspector) and four (4) separate vehicle strikes on U.S. Mail receptacles of a REGISTERED AGENT for a CORPORATION OF THE UNITED STATES to interfere in civil process affecting over \$100,000 USD; are component to the explicit threats by he parties sharing the prior video obtained by Donald Jonathon Beal for purpose of extortion and human trafficking.

Our office has become aware of the activity of the prior firms due to abuse of their networks by employees and contractors and officers of record shown on public resumes released by those persons expressly; and such information suggests an unregistered labor organization with political and racial extremist views against which all competent Corporations and Officers of the United States should suppress and resist.

Racism in the guise of ad hominem abuse and professional service harassment, and where in this case enjoined with **knowingly false gender representation of competitors to gain commercial advantage** as to portray NATIVE AMERICANS as homosexual, transgender, or otherwise mentally deviant due to their hair or ethnic traits in mixed race children – is repugnant and a felony hate crime where child taking or violence are incorporated in this abuse.

We urge all our clients and vendors to regard this activity, and to conduct themselves according to the appropriate response to organized hate crimes in these ongoing derogatory claims and effort to defend child snatching in human trafficking under color of law or abuse of law, a felony per 22 U.S. Code §7102 and 18 U.S. Code §1589.
