MEMORANDUM:
House Bill 484 - Democratic Sedition

It has come to my attention that the DEMOCRATIC PARTY has filed a [Bill H.R. 484](#). This bill suggests sedition against the UNITED STATES by direct legislative consideration of violation of DOUBLE JEOPARDY and DUE PROCESS.

The bill would impose as law a loss of CIVIL HONORS without 'conviction', based on the number of 'allegations' made against a UNITED STATES CITIZEN, and is a BILL OF ATTAINDER directed toward DONALD J. TRUMP.

An **Impeachment** per **Black's Law Dictionary** means literally "allegation", not conviction or any sort of guilt or penalty.

Further, is this bill on face a BILL OF ATTAINDER, so barred by ARTICLE I of the bylaws of the United States, a nation.

On face, this bill is a criminal sedition not afforded the CONSTITUTION OF THE UNITED STATES and a confession of gross criminal intent of the DEMOCRATIC PARTY in 2021 February.

Pursuant our prior policy of SANCTIONS, shall all SEVEN ALPHA portals and registrants hereby disqualify from all civil honors pursuant to the FOURTH GENEVA CONVENTION any honors, privileges, and right to work as afforded International Law and 76 O.S. § 76-9, so afforded 21 O.S. § 21-8 rights of persons themed INHERENT RIGHTS, and direct assault upon those rights affording the victims as a class, the American People, to 22 O.S. § 22-31 and similar remedy.

MEMBERSHIP in the DEMOCRATIC PARTY in any form or affiliation so determined by SEVEN ALPHA from 2021 August 10th to present, shall void member benefits and member standing - without exemption in writing granted for special dispensation and witness protection necessary to prosecute the parties engaged in widespread terrorism and open fraud.

Fraud in this matter is described in RTI DOCUMENTS entitled "The Circle", a foreign theory of law by the PEOPLE'S REPUBLIC OF CHINA, so described as "Ruism" (a secular religious theory barred by PERFECT TOLERANCE clause of the Oklahoma Constitution, Article II), and herein attached. Oklahoma statutory law speaks to this abuse in 21 O.S. § 21-1266, as a form of unlawful conduct and reduction in protected RIGHT TO WORK and other privileges, prohibited any aid or comfort by commissioned agents of the STATE OF OKLAHOMA or corporations resident therein belonging to the UNITED STATES or other competent foreign power.

Further, will residents in STATE OF TEXAS, STATE OF ARKANSAS, STATE OF MICHIGAN, and STATE OF CALIFORNIA be barred henceforth from use and access to the SEVEN ALPHA network citing their direct support of this rebellion, insurrection, and treason against the Federal Union and rights of the STATE OF OKLAHOMA or the People so reserved in 1907 in that Constitution endorsed by the UNITED STATES in formal admission.

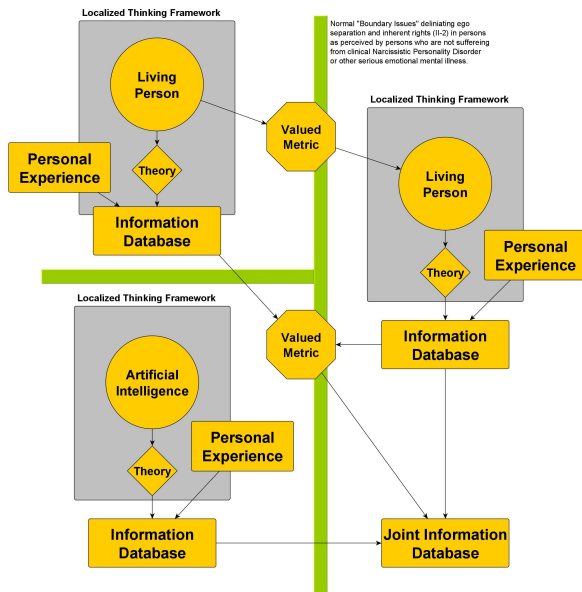

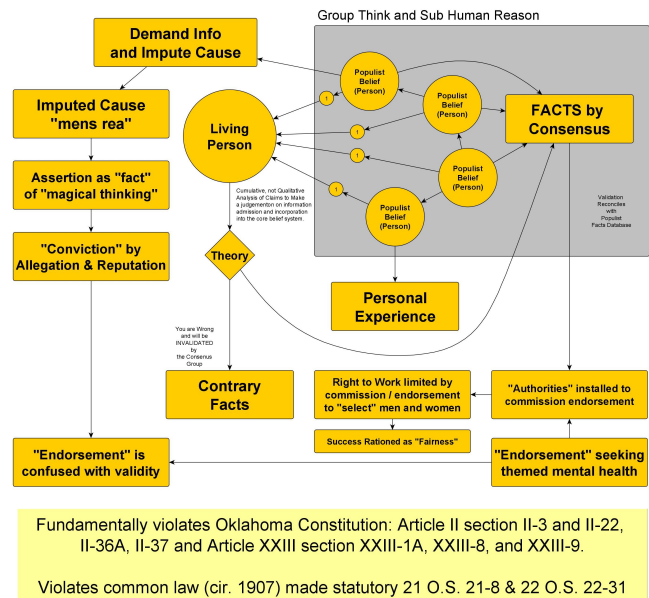
